

We are pleased to announce, after consultation with PGA TOUR medical advisors, that due to the high rate of vaccination among all constituents on PGA TOUR as well as other positively trending factors across the country, testing for COVID-19 will no longer be required onsite starting at the **3M Open**.

Onsite testing capabilities will be available for symptomatic individuals. Therefore, it remains imperative that individuals notify the TOUR if they are experiencing COVID-19 related symptoms.

***Please Note: All onsite testing will continue on Korn Ferry Tour.**

**** Advance Registration is still required to attend the event.**

PROTOCOL

Protocol for Fully Vaccinated Individuals:

- Once fully vaccinated, individuals should upload a copy of their vaccination record to their Healthy Roster account
- Fully vaccinated individuals who have been in close contact with someone who has COVID-19 do not need to quarantine unless they have symptoms
- **All constituents are required to report any COVID-19 related symptoms to the TOUR by emailing HealthandSafety@pgatourhq.com**
- In accordance with CDC guidelines, fully vaccinated individuals are not required to wear a mask indoors or outdoors unless otherwise mandated by state or local law or regulations
- The TOUR may conduct periodic testing of all constituents or as required by local health authorities

Protocol for Unvaccinated Individuals:

- All onsite testing operations will discontinue beginning with the 3M Open, the week of July 19
- In accordance with CDC guidelines, unvaccinated individuals should wear a mask indoors at all times and outdoors when they cannot be socially distant or as otherwise mandated by state or local law or regulations
- Unvaccinated individuals who have been in close contact with someone who has COVID-19 must notify the TOUR and follow TOUR contact tracing protocol
- **All constituents are required to report any COVID-19 related symptoms to the TOUR by emailing HealthandSafety@pgatourhq.com**

Individuals are considered fully vaccinated:

- 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine
- For clarity, the second dose with Pfizer or Moderna or single dose with J&J would be considered Day Zero and fully vaccinated would be considered on Day 15

SYMPTOMATIC TESTING

- COVID testing will be available onsite for individuals that develop symptoms while at a tournament
- If symptoms arise, individuals should notify the TOUR directly through HealthandSafety@pgatourhq.com

- If an individual is symptomatic and tests positive onsite, they will need to immediately leave the property and follow CDC quarantine regulations
- Positive individuals will not be retested

INSIDE THE BUBBLE ACCESS – Registration Required

Limited access “Inside the Bubble” will continue at least through TOUR Championship

- Advance registration is still **REQUIRED** through the Player Support site: <https://playersupport.pgatourhq.com/>
- Lanyards and wristbands are required to access “Inside the Bubble” areas and will be available for pick up at the Confirmation Tent onsite. Tournament-specific location details will be communicated in advance.
- Practice Area Cards will continue to be required to be inside the Practice Areas
- Access to facilities including locker room, media center and clubhouse continues to be restricted
